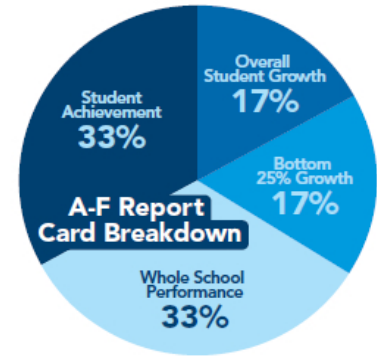

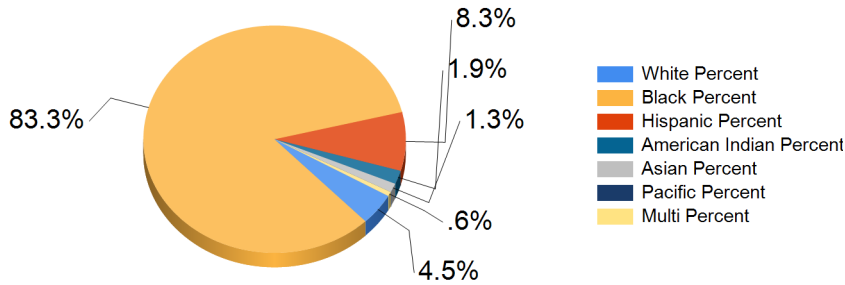

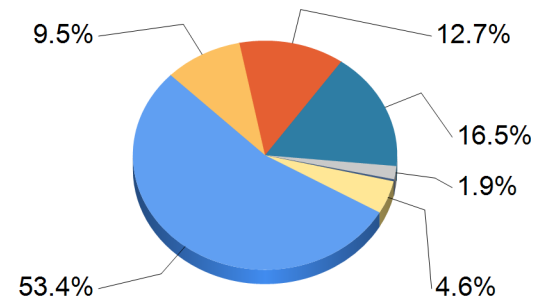

ETHNICITY BREAKDOWN

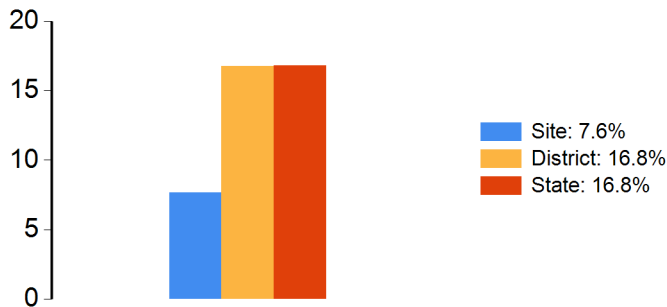


STATE ETHNICITY BREAKDOWN



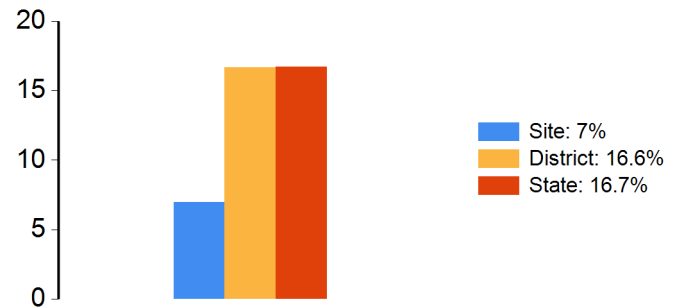

PERCENT TESTED ON IEP (READING)



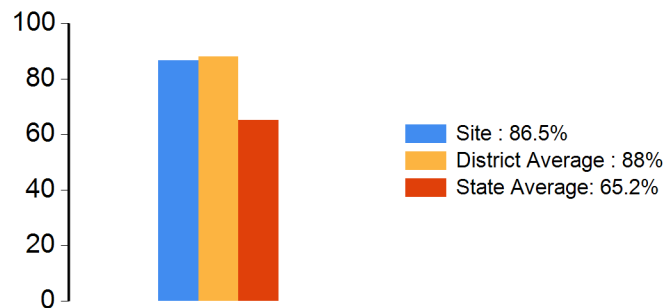
